Contractor must submit to the Village a current Certificate of Eligibility issued by the Illinois Department of Transportation for Work Category 012 (Drainage) prior to obtaining bidding documents for this project. Please note: Bid submissions received from firms that do not have a Certificate of Eligibility for the Work Category identified herein will be returned to the bidder unopened. Additionally, Bidders shall refer to the References portion of the Standard Terms and Conditions. Bids may be rejected if Bidder does not have a minimum of three (3) years' experience completing municipal water main construction with contract values of \$1 million or larger.

Scope of work: HMA pavement reconstruction and replacement, approximately 2,518 LF of water main installation, approximately 320 LF of storm sewer installation, miscellaneous sanitary sewer improvements, concrete curb and gutter construction/replacement, sidewalk construction/replacement, driveway replacement, parkway restoration, and other miscellaneous items of work.

All bids shall be accompanied by a Bid Bond for not less than five percent (5%) of the bid amount. The successful bidder must furnish a satisfactory performance and payment bond in the full amount of the bid.  
**A scanned copy of the bid bond must be included in the pdf file submission.**

**All work under this contract shall comply with the Prevailing Wage Rate Act of the State of Illinois, 820 ILCS 130/1 et seq. and Employment of Illinois Works on Public Works Act (30 ILCS 570/0.01 et seq.).**

Offers may not be withdrawn for a period of ninety (90) days after closing date without the consent of the Board of Trustees.

Any Bid submitted unsigned, **via mail, via in person delivery**, via fax, via email or received subsequent to the aforementioned date and time, **may be disqualified and returned to the bidder.**

The Village of Glenview reserves the right to reject any and all bids or parts thereof, to waive any irregularities or informalities in bid procedures and to award the contract in a manner best serving the interest of the Village.
