A **mandatory** Pre-Bid Conference Call of all prospective Bidders and/or their representatives will be held on November 17, 2020 at 10:00 A.M. Bidders are **required** to attend and participate in the conference. Pre-Bid Conference call-in attendees Dial: 815-516-0257, when prompted dial conference ID: 706097454#, follow additional prompts until conference leader joins the call and begins the Pre-Bid Conference.

**Description of Work**

The proposed construction consists of installing approximately 190 lineal feet of 6-inch, 4,683 lineal feet of 8-inch, 5 lineal feet of 10-inch, and 42 lineal feet of 12-inch ductile iron water main, including new hydrants, valves, and water services; horizontal directional drilling of water services; lawn and pavement restoration; and other miscellaneous items of work.

**Information for Bidders:**

All pertinent documents may be examined at the Office of the City Clerk, City of Joliet Municipal Building, 150 West Jefferson Street, Joliet, Illinois 60432 between the hours of 8:00 A.M. and 4:30 P.M., Monday through Friday. Hard copies will not be available for purchase. Electronic copies of the Bidding Documents can be downloaded free of charge at <https://www.joliet.gov/departments/finance/purchasing/bids-proposals>.

All Bidding Document holder should sign up for RSS feeds at <https://www.joliet.gov/departments/finance/purchasing/bids-proposals/construction-public-utilities> and provide first and last name and email address to automatically receive addendums. Addendums will also be posted on the City of Joliet's website at <https://www.joliet.gov/departments/finance/purchasing/bids-proposals>. The potential Contractor remains responsible for obtaining all addenda to the original specifications and should check the specific bid page before submitting a bid to ensure they have received all addenda.

Prequalification pursuant to Ordinance No. 7345 is necessary. Bidders are required to be pre-qualified through the Illinois Department of Transportation, the Capital Development Board or the City of Joliet. It is the responsibility of the bidder to ensure that their pre-qualification information is provided to the City of Joliet Purchasing Division prior to the bid opening. If bidders are not prequalified through IDOT or Capital Development Board, then they must be prequalified with the City of Joliet. Financial prequalification forms can be obtained from the City of Joliet website at <https://www.joliet.gov/departments/finance/purchasing/prequalification-process>. The current price for City of Joliet prequalification is \$175, which offsets the costs for independent auditor review of the documents.
