Zubair has over 31 years of progressive transportation engineering experience with in-depth and extensive knowledge of program administration, project management, supervision of design, technical review, and construction. He served the Illinois Department of Transportation for 17 years and the Indiana Department of Transportation for 12 years, spending much of his career as a supervisor overseeing all aspects and phases of highway engineering projects from development to closeout. Zubair spent 17 years in charge of the Eastern Division of Bureau of Local Roads & Streets in Program Administration of Federal & MFT funds for Cook County and City of Chicago including Phases I, II, and III, programming, agreements, invoicing, and closeouts. He managed several high-profile projects in Chicago, including Phase I and II engineering for the \$250M Obama Presidential Center Jackson Park Mobility Improvements, the feasibility study for the O'Hare Express Service Improvements, the \$300M Phase II design of the Upper and Lower Wacker Drive Reconstruction project, and the Phase II design of the Touhy Avenue Improvements (Elgin O'Hare Western Connection). Zubair's thorough understanding of IDOT policies and procedures will help to streamline reviews and approvals.
